**DRIVER SAFETY COURSE**

APPROVAL WILL NOT BE GIVEN OVER THE PHONE

**DO NOT TAKE A COURSE WITHOUT WRITTEN APPROVAL FROM THE COURT**

AT THE JUDGE'S OPTION you may request to take a drivers safety course to dismiss a moving violation if the written request is in the Judge's office by the appearance date on the citation.

If you hold a commercial driver license or cited in a construction zone (workers present) you are not eligible for a Drivers Safety Course.

Requirements for Driver Safety Course

1. Valid Texas Drivers License
2. Proof of Liability Insurance
3. Cited for less than 95 MPH
4. Cited for less than 25 MPH over the posted limit
5. Not taken DSC in the past 12 months prior to citation date

( ) I hereby request to take a Driving Safety Course. Enclosed is my proof of liability insurance, photo copy of my Texas driver's license and money order or cashiers check in the amount of \$146.00 court cost payable to Justice Court.

Do not pay fine amount if requesting defensive driving, only court cost of \$146.00 is required.
